

Royalty Addendum for Legacy Bookseller Discount Program v1.0

This is an ADDENDUM to the base PUBLISHING AGREEMENT between the author ("AUTHOR") shown below and iUniverse, Inc., a Delaware corporation, with its principal offices at 1663 Liberty Drive, Suite 300, Bloomington, Indiana 47403 ("PUBLISHER") for the WORK listed at the end of this Agreement ("WORK").

Royalty Rate

On all sales of printed copies of the WORK in the paperback format, the PUBLISHER will pay the AUTHOR a royalty equal to ten percent (10%) of the payments the PUBLISHER actually receives from sales of printed paperback copies of the WORK, less any refunds and returns. Royalties will not be paid on copies provided or sold to the AUTHOR.

On all sales of printed copies of the WORK in the hardcover format, the PUBLISHER will pay the AUTHOR a royalty equal to twenty percent (20%) of the payments the PUBLISHER actually receives from sales of printed hardcover copies of the WORK, less any refunds and returns. Royalties will not be paid on copies provided or sold to the AUTHOR.

Contract Submission Guidelines and Payments

AUTHOR shall follow all the submissions procedures and payment requirements attached in Schedule A.

Submission Acceptance

PUBLISHER reserves the right, in its sole discretion, not to accept a Legacy Bookseller Discount Program Contract ADDENDUM upon receipt. If this is the case, the PUBLISHER will refund the AUTHOR the Legacy Bookseller Discount Program submission payment, but the PUBLISHER has no obligation to return the contract package or other materials.

General Terms

This ADDENDUM shall be effective as of the date below and shall constitute an amendment to the base PUBLISHING AGREEMENT that the AUTHOR and PUBLISHER have entered into for the WORK. Except to the extent as expressly defined or otherwise modified herein, the base PUBLISHING AGREEMENT shall remain in full force and effect and always take precedence over this ADDENDUM.
